



ECVC Privacy & Data protection Policy

In the context of new data privacy rules that came into force in the European Union on 25 May 2018, we wish to inform all our subscribers a few things:

The General Data Protection Regulation (GDPR) in the EU is an appreciable effort to check the misuse of internet users' personal online data. As a provider of online information, the European Coordination Via Campesina, headquartered in Rue de la Sablonniere 18, 1000 Brussels, Belgium, takes the protection of your personal data seriously and strictly complies with data protection law.

The following statement gives you an overview of how we ensure such protection and what types of data are collected for what purpose.

Newsletter, Stay informed subscriptions, mailing lists

If you have subscribed to our newsletter or the “stay informed box” on our website, the only data we hold of subscribers is your email address, your name (in full or in parts) and language preference, if you provided this while signing up. We do not store any other personal data of subscribers and will not share the information that we do hold with third parties.

This newsletter and info list is used exclusively for the sending of information concerning the non-profit activities of our organization. You are free to unsubscribe at any time from the mailing list by sending an email to info@eurovia.org.

In accordance with this policy, we confirm that the data collected by ECVC is only used for information purposes on our part, and will under no circumstances be transmitted to third parties.

In accordance with the GDPR regulation, we delete all of your private data related to the ECVC's info lists and/or newsletter upon receipt of your unsubscribe request.

During events and other actions, or if you have called or emailed us regarding our work and campaigns, we might have asked you to provide personal information that will enable us to contact you with material you requested or that may be of interest to you. Whenever we organize an event inside a public institution and you wish to attend or we launch a petition, personal data will be demanded.

These and other data you provide will only be used in line with your request.

HTTP cookies

Data may be collected by third-party providers (Facebook, Twitter, Flickr, Youtube) via cookies on various pages of www.eurovia.org. You can prevent that by blocking cookies of third-party providers in your browser settings ([instructions here](#)).

When using online services, data is generated. This data is transmitted to us by your browser and are stored in the log files of the web server. This data includes:

- browser type/version
- operating system used
- referrer URL (last visited page)
- time of the server request
- anonymised IP address

Cookies are always placed on the browser of the person that connects to www.eurovia.org and is stored indefinitely in the browser.

Each time a browser connects to the site, it will send the cookie to the site so that the latter can use it. The eurovia website sends 4 cookies:

resolution : deleted at the end of the session (when you leave the browser)

_ga : remains 2 years

_gid : 1 day

_gat : 1 minute

Web analysis

ECVC uses the open source software "[Matomo](#)" for web analysis. This is a safe software with respect to data protection – collected data, such as the number of visitors, page clicks, search terms, referrers, entry pages, exit pages and IP addresses, are stored on the server of an independent provider for the purpose of statistical analysis for ECVC and are not misused for other (e.g. commercial) purposes.

Right to information

You have the right at any time to information about the data stored concerning your person, the origin and recipient of such data, and the purpose of the storage. In addition, you may, of course, withdraw

your consent to the collection and storage of your personal data at any time. In such cases, please contact:
